VII. DISCUSSION OF FY 2021-2022 BUDGET

1. Increasing Property Taxes and 2021-2022 Budget
2. 2021-2022 Police & Fire Special Assessments

Mr. Neyland introduced himself as the new Finance Director and Assistant City Manager City of Fraser. He begin employment approximately one month ago.

Mr. John Walters, Acting Interim Finance Director City of Fraser, advised that the budget was created with input from Mr. Neyland and Mr. Thompson. He spoke with several department heads, incorporating their needs in this budget. His presentation was high level and focused on the General Fund.

Mr. Walters believes the City should receive between \$1 million and \$2 million in grant funding the next two fiscal years. Additionally, Mr. Walters created a new fund, Capital Projects Fund.

Ms. Schornak asked if the Fire Department equipment could come from non-general fund accounts. Mr. Walters thought that it probably could. Ms. Schornak believes that is the way it should occur.

Ms. Kalka inquired about the Kelly Rd. project. It is important to address now because Kelly Rd. is not on the Capital Projects Fund. Ms. Baranski inquired if it would come from roads as opposed to capital. Mr. Walters stated that none of the road projects are included on the schedule because they would be Capital items in fund 202 or 203.

Ms. Kalka discussed Public Act 33 and its ramifications. Ms. Baranski echoed Ms. Kalka's opinions related to Public Act 33.

Mr. Lesich discussed administrative fees. He believes administrative fees are higher than they have historically been.

Mr. Thompson discussed the budget and its purposes. He believes it is a planning document. In one year, the budget will be much better. Mr. Thompson advised that Council look carefully about the long-term implications of reducing revenue sources.

VIII. REVIEW ACTIONS NECESSARY TO ADOPT FY 221-2022 BUDGET

Mr. Lesich asked Mr. Walters questions related to commodity and fixed rates. Discussion related to a Plante Moran study from several years ago occurred.

IX. CITIZEN PARTICIPATION


Mr. Carnegie opened the meeting to public comments. No members of the public spoke.

X. ADJOURNMENT


MOTION by Winowiecki, second by Kalka, to adjourn the Special City Council Virtual Meeting of April 15, 2021, at 8:27 p.m.
